SANTHOME PUBLIC SCHOOL " Fire-Fighting arrangements provided were found in satisfactory working condition as per certificate issued by the Licensed Agency (Ref. No. 3.)

- 1) 5 Hp Booster pump & Accessories located on terrace adjoining overhead tank with a Positive suction - 2 Nos.
- 2) Single Hydrant Valve - 9 Nos.
- 3) Branch Pipe - 2 Nos.
- 4) Canvas hose pipe with male female coupling - 2 Nos.
- 5) Single Door hose box - 2 Nos.
- 6) Hose reel drum with thermoplast pipe with shut off nozzle - 8 Nos.

Considering the same this Office is issuing Renewal of final No Objection certificate for the above mentioned building. This Certificate shall be treated valid up to 31/12/2025. It is the responsibility of the owner / Architect / occupier to get the same renewed every year from the Fire Brigade Department after submitting inspection Report from Licensed Contractor twice in a year that is on 1st January and on 1st July. After paying renewal fees Fire Brigade Department will renew the Final No Objection Certificate. In failure of fulfilling the requirement of Fire Department, the owner / Architect / occupier will be personally responsible.

The Chief Fire Officer Reserves right to amend any additional recommendations deemed fit during the stage wise inspection due to statutory provision amended from time to time and in the interest of the protection of the building / People.
